BOARD OF TRUSTEES

VI. ANNUAL GENERAL BODY MEETING:

There shall be an Annual General Meeting of the Board of Trustees once in a year to review the activities of the Trust.

Audited annual statement of accounts and annual report of activities of all the institutions shall be presented by the Deputy Managing trustee for consideration and adoption. There shall be 15 days notice for the meeting and the quorum shall be two.

VII. ACCOUNTS & AUDIT

The financial year of the Trust shall be April to March. The accounts shall be audited by a Chartered Accountant or by a firm of Chartered Accounts in accordance with the provisions of the Income - Tax Act and other Act applicable to trust. The Board shall appoint one or more auditors to audit the accounts of the trust and its institutions and fix their remuneration. All funds of the trust shall be invested in banks or securities in accordance with the provisions of the Income tax or any other Act /s applicable to charitable trusts.

The trustee shall from and out of the income realized from the properties of Trust, and from such other endowments / grants which may be received from Government and donor agencies from time to time expend such sum/ s of money as they may deem fit to carry out the objects of the trust.

The fund of the trust shall be utilized solely towards the objects the trust and no portion of it shall be utilized for payment to trustees by way of profit, dividend, etc,

VIII. POWERS AND DUTIES OF THE TRUSTEES:

The trustees shall be in complete Management of the affairs of the Trust.

The board of trustees may from time to time make rules, and by laws for the conduct of the business and administration of the trust.

- To donate funds to institutions having same objects and to other welfare schemes of both government and voluntary organizations.
- To receive donations in any form.
- To purchase or take on lease land, building, and equipment's, materials and other items.
- To erect and maintain buildings and other construction and to sell, mortgage, dispose of or otherwise deal with any or all of them as the trustees may think fit and proper.
- To grant loans or borrow money as they may think fit and proper to control and manage the assets of the trust.
- To constitute any committee or sub-committee/s from among the members of from outsiders and to invite eminent persons in the field to be the advisors.
- To execute, become party to, sign, acknowledge, perfect and registrar all deeds, contracts, amounts, receipts, and other documents and writings and to give effectual, debenture stocks and other securities.

- To draw, make, endorse, negotiable, execute and issue promissory notes, bills of exchange, hundies, cheques, Government securities and other negotiable instruments.
- To borrow from time to time such sum or sums of money at such interest for such period and on such terms with or without security as the Trustees may think fit and secure payment there of with interest by mortgage or by issue of bond, promissory note, bills, hundies or other negotiable instruments. - To appoint from time to time, employees with such powers and duties and upon such terms as to duration any or such of them as the Trustees may think proper and necessary.
- The trustees shall be entitled to receive upon such terms and conditions as they may deem fit, donations, gifts, subscriptions in cash or in kind and to collect funds by Public or private appeal for carrying out the objects of the Trust.
- Every Property of the trust, movable or immovable shall be kept in the name of the trust.
- Whenever any trustee resigns or dies or becomes insolvent or incense or is so convicted of a criminal offence involving moral turpitude or desires to be discharged from or refuses or becomes unfit or desires to be discharged from or refuses or becomes unfit or incapable of acting them in every case, the surviving on the continuing trustees or trustee for the time being shall be entitled to appoint a trustee in the place of such Trustee becoming insolvent or being convicted.

- Any funds from Overseas sources will be obtained in a separate account and that funds will be utilized after getting the Trust registered Permanently with the prior permission, from the Ministry of Home Affairs, Government of India, New Delhi under the funds from Foreign Contribution and Regulation Act 1976 and the audited accounts for the funds from foreign sources, shall be submitted in the prescribed forms as per the Foreign Contribution (Regulation) Act 1976.

XI. AMENDMENT

Any amendments in this Trust Deed of the Trust shall be carried out and implemented only with the approval of the Commissioner of Income Tax. An amendment carried out and implemented without the approval of the Commissioner of Income Tax shall be deemed to have never been passed and the power of amend the trust deed given to the trustee would not extend to the altering the basic character / objects of the trust and no such amendments which may prove to be repugnant to provision of the section 2(15), 11, 12, 13 & 80G of the Income Tax Act 1961 shall be made.

XIII. DISPUTES AND ARBITRATION

All disputes arising between themselves and the disputes between the Trust and its employees on any matter or subject relating to the affairs of the trust or its institutions shall be decided by a board of three arbitrators

appointed by the Board of Trustees from time to time and the award of the arbitrators on such matters shall be final and binding on all the parties concerned.

APPEAL: Except on ground referred to in Sec. 30 of the Arbitration Act, 1940 no appeal would lay against the Board of Arbitrators.
